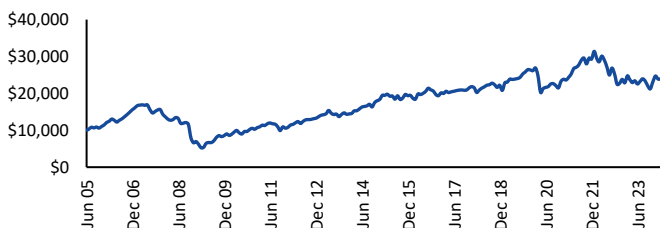

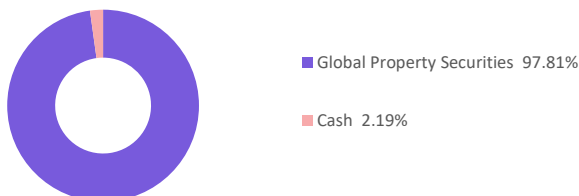

### Performance chart (\$10,000 invested since inception)

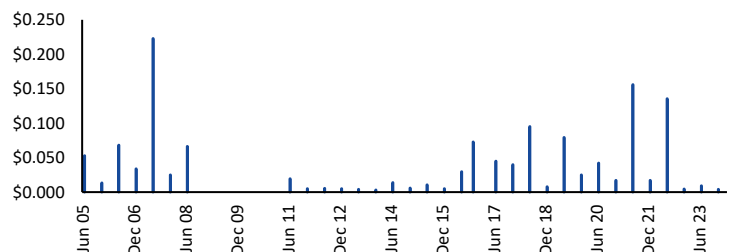

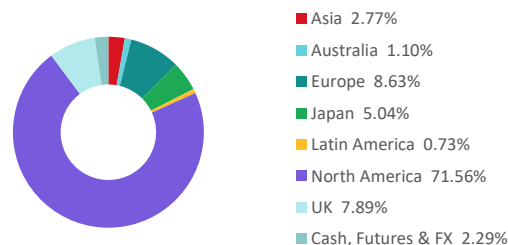
### Asset allocation
